Homeward Bound	(214) 941-3500	Intake Hours 8AM - 11am. If necessary go to local ER first. Offers 5 day de-tox. Medically supervised. Three options: 1.) De-tox and leave 2.) After de-tox Blue House (40 day stay) 3.) Stay At Homeward Bound, go through Rehab (some court sent residents)
